Loading... WASHINGTON,D.C. -- August 12,2024 -- In a strategic move to strengthen the U.S. solar industry,President Joe Bidenissued a proclamation today expanding the tariff-rate quota (TRQ) on imports of crystalline silicon photovoltaic (CSPV) cells.

Which bifacial solar panels are excluded from USTR?

Effective June 13,2019,the USTR excluded bifacial solar panels that absorb light and generate electricity on each side of the paneland that consist of only bifacial solar cells that absorb light and generate electricity on both sides of the cells (bifacial modules).

Will bifacial solar panels be exempt from the safeguard measure?

The Proclamation also preserves the exemptionof bifacial solar panels from the safeguard measure,and authorizes the US Trade Representative (USTR) to negotiate agreements with Canada and Mexico that could lead to the exclusion of those countries from the safeguard remedy. This alert provides an overview of the Proclamation.

Will bifacial CSPV panels be excluded from the safeguard measure?

The Proclamation also maintains the exclusionof bifacial CSPV panels from the safeguard measure. The Trump Administration first granted the exclusion in June of 2019,but subsequently attempted to withdraw the exclusion after finding that it had undermined the effectiveness of the safeguard measure.
